## Technical/Financial Eligibility criteria

- 1. Bidder should provide the One Year warranty for the machinery.
- 2. Bidder should provide at least one-week training for operation and maintenance of preprocessing equipment.
- 3. The Applicant, whether a single entity or all members therein should be a legal person, which may be Proprietorship, Company, Partnership Firm and Limited Liability Partnership Firm.
- 4. The Bidder(s) shall be a Pvt. Company/Partnership Firm/ Limited Liability Partnership (LLP)/ Registered proprietorship firm incorporated in India under the (Indian) Companies Act 1956/2013 and incorporation should not be less than 5 years old. The bidder shall be required to submit a true copy of its incorporation certificate.
- 5. NGO, societies and other Govt. organisations are not allowed to participate.
- 6. Bidder should have experience in supply and installation of waste related machines.
- 7. joint venture /Consortium are not allowed to participate.
- 8. Bidder in the capacity of a subsidiary as a single entity is permitted to use the credential of its parent Company and/or its sister subsidiary company/companies. Also, Applicant in the capacity of a parent company as a single entity is permitted touse the credential of its subsidiary company / companies.
- 9. Bidder should have experience of running MSW related machines in fresh waste/ legacywaste of minimum 250 TPD for atleast 1 year in last 5 years.
- 10. The Bidder should not have been barred by the Central Government, any State Government, a statutory Authority or a public sector undertaking, as the case may be, from participating in any project, and the bar subsists as on the date of the Proposal.
- 11. The Bidder should have, during the last three years, neither failed to perform on any agreement, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Bidder, nor been expelled from any project or agreement nor have had any agreement terminated for breach by such Bidder. An undertaking (Self Certificate) is to be submitted for the same.
- 12. The Bidder must be registered in Income Tax Department & Must have a Valid GST registration certificate attached otherwise the bidder will be treated as disqualified.
- 13. The bidder should have average Annual Turnover in the last three years (3) i.e., 2020-21, 2021-22, 2022-23 not less than 5.00 Cr.
- 14. Bidder Should have Net worth/Bank credit/sanction letternot less than 1.25 Cr.
